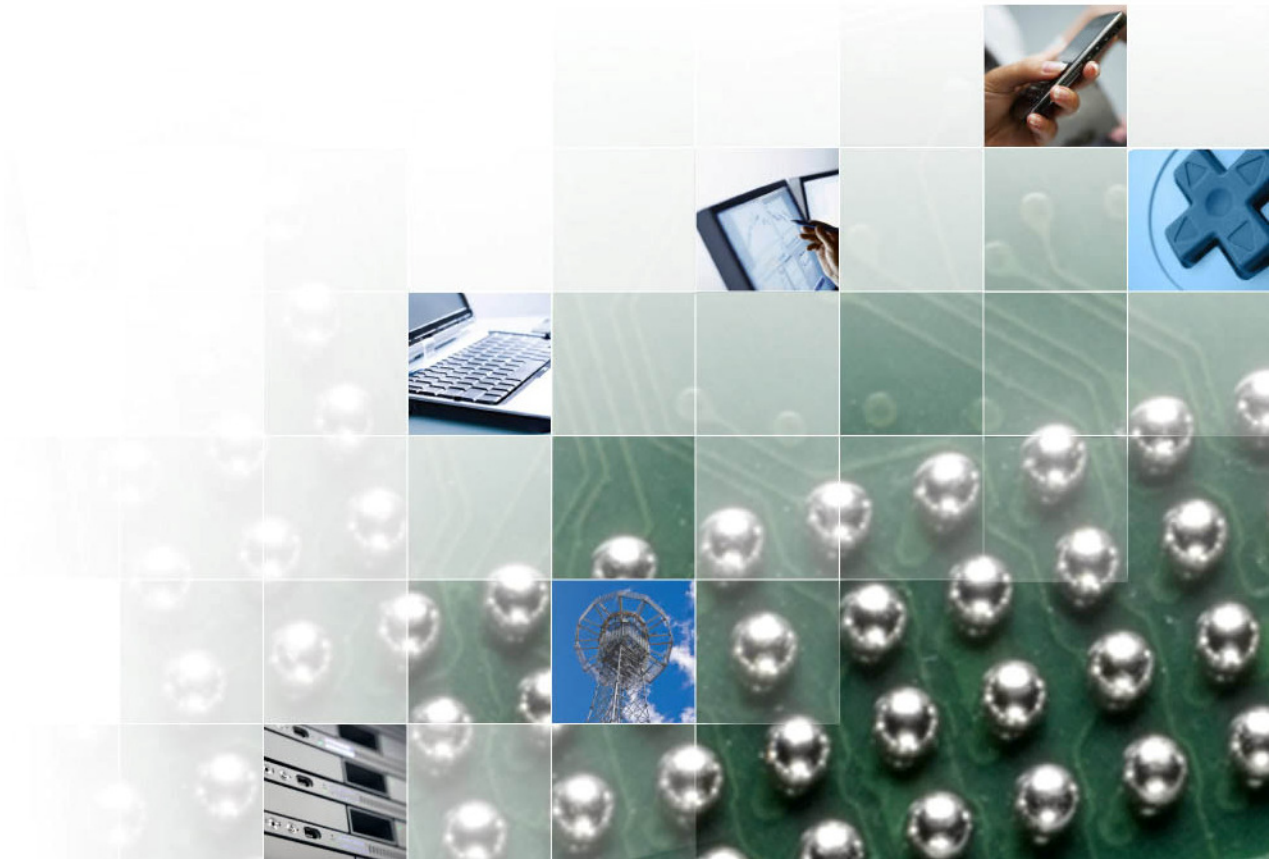




Q1 FY13 Financial Results

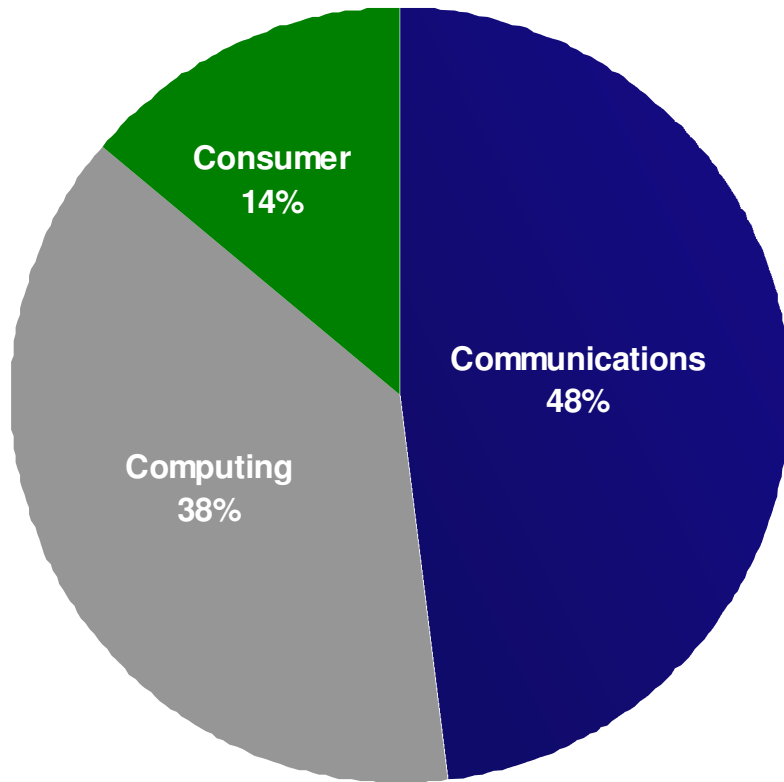

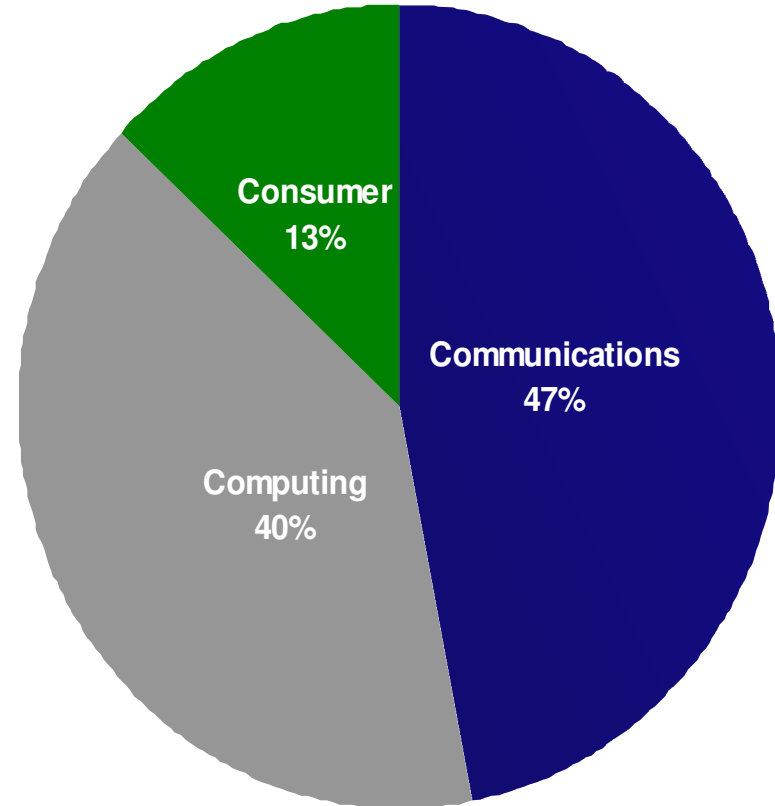

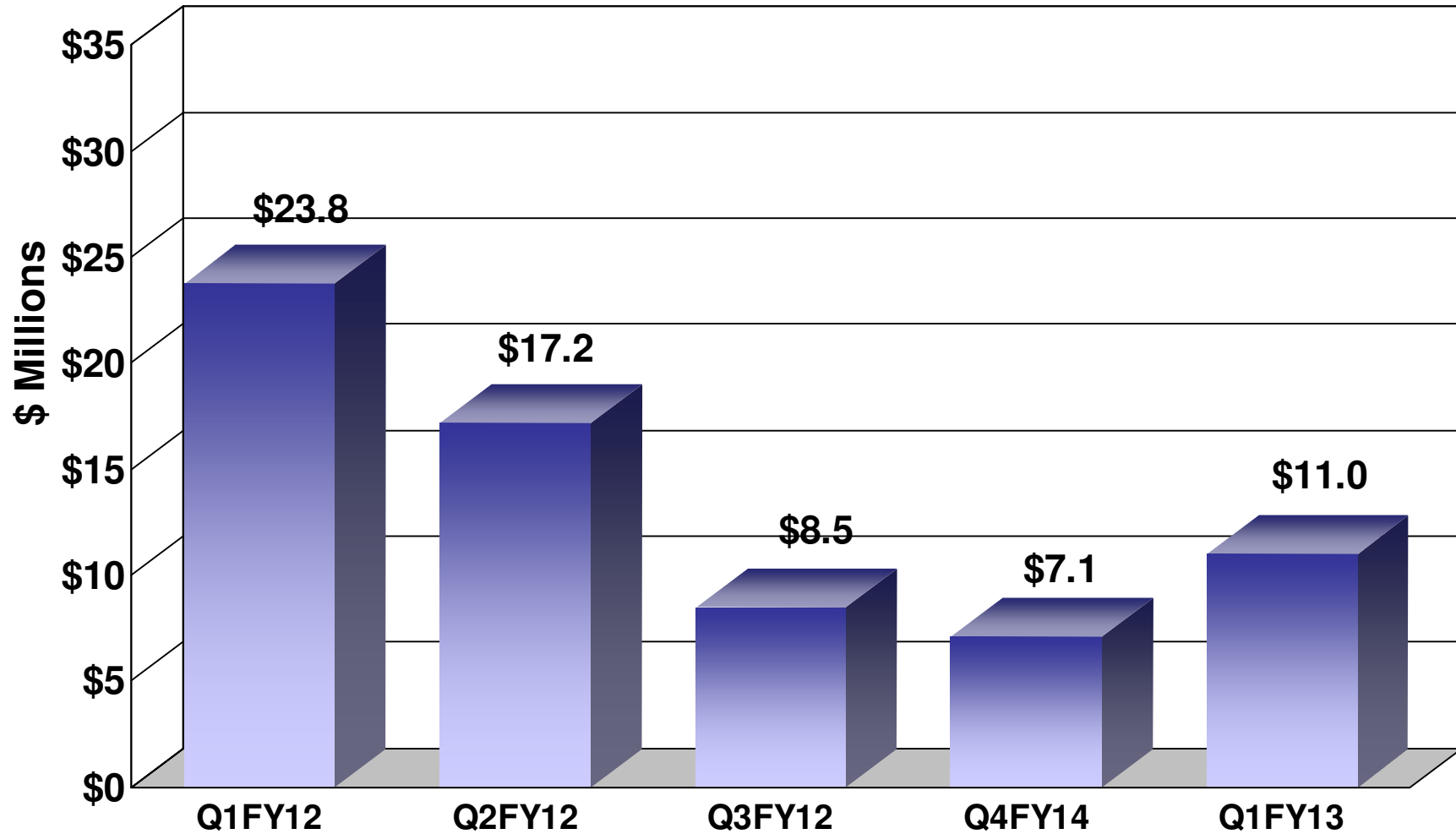


Fiscal Q1 2013
